- Increasing enrollment in vocational business classes
- Maintaining strong membership numbers and participation in FBLA
- Upgrade for technology and equipment through use of FV4 funding

Recommended changes needed to achieve the goals and objectives of the program:

- Matching funds from district for upgrades of equipment and technology purchased with FV4 grant money.
- Adjustment of yearly schedule so that more students can participate in vocational classes

Action to be taken:

- Figure a way to have completers in the business area to continue to apply for FV4 grant money to upgrade equipment and technology
- Meet with counselor and principal to arrange schedule

Change made in the last two years:

#### **2025-2026**

- Middle School Exploratory Business & Computer Science class returned
- Used FV4 50/50 funding for school license for Adobe Creative Cloud and additional technology equipment for Multimedia class
- Continued to offer Middle Level (middle school) FBLA chapter. All members (11) competed in three events (individually and as part of groups of 2-3) for State Leadership Contest in March. Two students immediately qualified for Nationals by placing in the Top 4 of their event. Several others are possibly moving up to compete at Nationals. All participating members placed in the Top 10 for at least one of their events. Almost all members completed at least one level of their LEAD Awards.
- Hiring 5 students to work on the Bus Café
- FBLA District Contests: 16 students competed and 9 students qualified for individual and team events for State Leadership Conference (April 12-14 in Springfield)
- Three students work on the Bus through FLEX program during first hour

#### **2024-2025**

- Used FV4 50/50 funding for school license for Adobe Creative Cloud, Lego First Robotics Challenge kits, and Hummingbird Robotics kits
- Added Computer Science to the class schedule to meet DESE requirements. Class will now be on course schedule every year
- Computer Science students participated in a live Cybersecurity lab event with Engineering Today
- Desktop Publishing collaborates with Agriculture and FACS programs on the Wedding Project
- Hired 4 students to work on the Bus Cafe

- Three students work on the Bus through FLEX program during first hour and one who works during 7<sup>th</sup> and 8<sup>th</sup> hours
- Bus Café continues to collaborate with Industrial Tech to offer drive-in movies during the school year
- Middle School FBLA members competed in State Contests. All students (six) who traveled to compete in the in-person events placed in the top 8 of one of their events. Several students have qualified to compete at Nationals.
- High School FBLA District Contest: Several students medaled by placing in the top 5 of their event. Several qualified to take objective tests and complete in in-person contests at State Leadership Contest in Springfield (April 13-15).
- Took 23 middle and high school FBLA students to FBLA event at Truman in October
